INTRODUCTION

- 1. By this memorandum, counsel for the Attorney-General:
 - 1.1 provide a revised version of the information that was provided to the Court on 2 June 2017 about the applications to the High Court for recognition orders under the Marine and Coastal Area (Takutai Moana) Act 2011 (the "Act"); and
 - 1.2 respond to Mallon J's further minute of 1 June 2017 in which the Court requested the Crown compile additional information about those applications.²
- 2. In addition, the Attorney-General respectfully proposes at [31] a series of preliminary interlocutory steps to apply to all applications.

Intitulment

3. The intitulment page of this memorandum refers to the *Elkington* application and, by reference to a schedule, to all other current applications to the High Court under the Act. In other cases with a large number of proceedings dealing with similar subject matter or issues that need to be managed as a group, the Crown has used this method of formatting in case management memoranda in order to avoid excessively long intitulments and seeks leave to do so in this case, too.

BACKGROUND

Court's directions of 11 April 2017 and information filed by the Attorney-General on 2 June 2017

4. On 11 April 2017, Mallon J made a number of procedural directions to assist the management of applications to the High Court under the Act for recognition orders. Amongst other things, Her Honour directed the

The information filed on 2 June 2017 was provided in response to a minute of 11 April 2017, which Mallon J issued in the context of applications concerning the Motiti rohe (CIV-2015-485-767; CIV 2016-485-770 and CIV2011-485-793).

This minute was issued in the context of the *Elkington* application (CIV 2017-485-218).

- Attorney-General to provide a tentative list of groupings of applications for case management purposes based on apparent overlapping areas.
- 5. Accordingly, on 2 June 2017, in response to the Court's directions, counsel for the Attorney-General filed a memorandum with annexures containing:
 - 5.1 a series of maps showing the approximate geographical area of each application under the Act to the High Court (with certain specified exceptions) and proposing 21 application groups for case management conferencing purposes;
 - 5.2 a spreadsheet containing information about each application, whether mapped or not mapped; and
 - 5.3 a table listing each of the High Court applications that falls within each proposed grouping.

High Court request for further information

- 6. To facilitate the management of applications, on 1 June 2017 the Court requested the Crown to prepare a more detailed schedule that:
 - 6.1 identifies the applications by type (customary marine title or protected customary rights);
 - 6.2 identifies for each application the area to which it relates;
 - 6.3 identifies for each application the relevant local bodies;
 - 6.4 identifies, where known, the date of public notice of each application;
 - 6.5 groups, as far as it is possible, each application into the following categories:
 - 6.5.1 applications that may be settled without requiring a hearing;
 - 6.5.2 applications which may have precedent value and lead to resolution of more than one application;

- 6.5.3 applications that may be heard together;
- 6.5.4 other case-specific applications that will not have precedent value; and
- 6.5.5 identifies the proposed venue for the substantive hearing for cases where it is anticipated a hearing may be required.

MATERIAL FILED WITH THIS MEMORANDUM

Revised version of material filed on 2 June 2017

7. The material filed with this memorandum replaces the annexures to the memorandum counsel for the Attorney-General filed on 2 June 2017.

Annexure A: revised maps

- 8. The information counsel for the Attorney-General filed on 2 June 2017 included maps³ that identified the area to which each application relates, with the exception of:
 - 8.1 those applications that purport to be for the entire common marine and coastal area (CMCA) of New Zealand;
 - 8.2 those applications over part or all of the CMCA on or near the Chatham Islands or other off-shore islands (such as the Auckland Islands or the Kermadec Islands); and
 - 8.3 those applications which contained insufficient information to be able to identify the application area, or which have not been mapped for some other reason.
- 9. The maps also proposed 21 application groups, labelled 'A' to 'U', for case management conferencing purposes.
- 10. In light of comments received from some applicants and further analysis the Crown has been able to undertake, a revised version of those maps is filed with this memorandum as annexure A. It is important to note that

- the maps are based on the information provided in each application and are indicative only.
- 11. The revisions made to the application areas on the maps are summarised at the end of the relevant parts of annexure B.
- 12. The maps have also been updated to show the boundaries of regional councils and those district councils with a coastline. The regional council boundaries are shown as thick grey lines and the district council boundaries are shown as thin, dashed grey lines.
- 13. The maps also now show the location of all High Court registries, except Blenheim, Greymouth, Timaru and Dunedin.

Annexure B: revised table of applications

- 14. Annexure B to this memorandum is a revised spreadsheet⁴ containing for each application:
 - 14.1 the number allocated to it on the maps in annexure A;5
 - 14.2 the CIV number;
 - 14.3 the applicant name (as it appears on the application);
 - 14.4 the district abutting the application area; and
 - 14.5 the proposed grouping ('A' through to 'U').
- 15. The revisions that have been made to the spreadsheet in annexure B are summarised at the end of each part of the annexure.

Annexure C: proposed groupings

16. Annexure C to this memorandum is an updated table that lists each High Court application that falls within each proposed grouping ('A' through to 'U').

The total number of applications to the High Court is 186. Of these, 171 are mapped and 15 are not mapped. Applications not mapped are listed in part 2 of annexure B.

Annexure D: coastal district councils

17. Annexure D to this memorandum is an index of district councils the territories of which have some coastline. The district councils are identified on the maps in annexure A by large, red numbers (1-52).

Annexure E: applications within regional council boundaries

18. Annexure E to this memorandum lists which applications fall within each regional council's boundaries, and within the boundaries of district councils or city councils where they function as regional councils.

Annexure F: type of application

19. Annexure F to this memorandum is a spreadsheet that identifies each application by type, that is, whether the application is for customary marine title ("CMT") or protected customary rights ("PCR"), or both. It also indicates whether the applicants for customary marine title also seek wāhi tapu protection ("WT").

Annexure G: addresses for service

- 20. Annexure G to this memorandum is a spreadsheet that provides the address for service for each application, including email addresses where they have been provided.
- 21. This information is included so that applicant counsel can approach their colleagues to obtain copies of applications that overlap, or might overlap, with their own client's application. Similarly, unrepresented applicants and interested parties may use that information to request copies of applications in which they have an interest.
- 22. A number of counsel have approached counsel for the Attorney-General seeking copies of applications in which their client might have an interest. However, it is more appropriate that such documents are provided by the relevant applicant's counsel, or by applicants themselves where they are not represented, or by the Court's registry in accordance with the High Court Rules.

Annexure H: applications for engagement with the Crown

23. Annexure H is an updated spreadsheet that counsel is instructed lists all applications for engagement received by the Crown.⁶

OTHER MATTERS

Date of public notice of applications

24. Counsel for the Attorney-General have been unable to collate dates of public notices of applications in time for filing this memorandum. Counsel will endeavour to file dates of public notice for each application, insofar as they are known, by 7 July 2017.

No applications identified that may proceed without hearing

- 25. At present, the Attorney-General seeks to be heard on all applications. Almost all the applications are at an early stage and counsel for the Attorney-General have had limited time to analyse them. It is apparent, however, that in many cases there are significant overlaps between application areas. The Attorney-General considers all applications must positively establish that the relevant statutory criteria are met.
- 26. The Attorney-General has not yet identified any application which he considers may be settled without further investigation, consideration of evidence and legal submissions.

Precedent value not possible to identify at present

27. The Attorney-General is not currently in a position to identify which applications may have more precedent value than others. This may depend on the particular evidence led by applicants and interested parties. Counsel for the Attorney-General are considering this point further.

Applications that may be heard together

28. The Attorney-General is not yet in a position to suggest which applications should be heard together. Counsel for the Attorney-General intend to complete this analysis in the coming weeks.

This spreadsheet was annexure E to the memorandum counsel for the Attorney-General filed on 2 June 2017.

Proposed venues for substantive hearings

- 29. Counsel for the Attorney-General respectfully submit the identification of venues for the substantive hearing of cases would be better undertaken later in the interlocutory stage, once a clearer picture is available as to which applications will proceed to hearing.
- While, as noted above, the maps in annexure A to this memorandum identify the location of all High Court registries (except Blenheim, Greymouth, Timaru and Dunedin), counsel are not to be taken as proposing that substantive hearings should occur at each of those venues. At this preliminary stage, counsel submit it is likely that hearings at a smaller number of High Court venues would be desirable in order to achieve some efficiency and seek leave to file further submissions on this point in due course.

Next interlocutory steps

- 31. The Attorney-General respectfully suggests that the following interlocutory steps would be appropriate for the orderly management of applications:
 - 31.1 First, a reasonable period of time perhaps six weeks should be allowed for applicants and interested parties (or potentially interested parties) to obtain copies of applications in which they have or might have an interest. As noted above, in order to facilitate that process annexure G of this memorandum provides the address for service for each application.
 - 31.2 Applicants and interested parties who wish to do so should then have four weeks to file memoranda listing applications in which they wish to seek to appear, setting out the grounds for their interest in that proceeding. Such memoranda will be treated as a notice of appearance for each proceeding (unless the applicant or interest party has already filed such a notice in a proceeding).
 - 31.3 The Attorney-General should then, within eight weeks, file and serve an amended notice of appearance for each application that

particularises the Crown's position (insofar as that is possible on the information filed with the Court).⁷

- 31.4 Applicants should then be given a reasonable opportunity to complete service, file amended applications, identify any proceedings they consider may be heard together and make any submissions as to which applications should be given priority. Before filing amended applications, the Attorney-General respectfully submits applicants may wish to give particular consideration to applicant group definition and the resolution of overlapping application areas between themselves.
- 31.5 The Attorney-General, and each interested party, should then advise which applications they consider should be heard together and make submissions as to priority.
- 31.6 Counsel suggest that a time table for the last two steps be settled once the preceding steps have been completed.
- 32. Once all steps have been completed, the first case management conferences should be able to be scheduled.
